#### RAPID REVIEWS IN 23/24

In 2023/2024 the CSPR Subgroup completed two Rapid Review. Both have involved contributions from across the partnership, and the NCSCP has also contributed to a rapid review held by Leicestershire & Rutland Safeguarding Children Partnership involving children with links to Nottingham.

Both NCSCP rapid reviews were for neglect and for children aged 3 and 10. Learning from these Rapid Reviews has been welcomed and action plans have been developed and implemented with reviews of our partnership practice as a result.

# **SNAPSHOT OF OUR YEAR**

#### Launched a Threshold of Need Toolkit

The updated 'Threshold of Need' document has been launched and made available across the partnership. Awareness raising sessions and training have been rolled out in 23/24.

# The Neglect Toolkit and Informational Videos

The NCSCP launched the revised Neglect Toolkit alongside two informational videos on neglect. One for professionals and the other for the public. Neglect continues to feature highly in our work.

#### **NCSCP Partnership Newsletter**

We set up our partnership newsletter in 2023 which has been widely received. The three published editions have had close to a thousand views. We have a 'shout out' section to highlight and recognise individuals that have been recommended from within the partnership for the 'shout out'.

### **Education Subgroup**

We established the 'education' subgroup to formally represent education within the work of the partnership. This group has representatives from across the education sector and the partnership working together to champion and lead on safeguarding matters of relevance to the sector and the partnership's business plan.

#### **Early Help Strategy and Website**

We worked with young people and families in understanding what good early help looked like and we used that to inform and design our new early help strategy and website funded by Family Hubs. The website is for families and professionals with information, advice, activity details and links for whole family services.
