47 Minutes

No comments or amendments raised for the minutes of the meeting held on 12 October 2022. John apologised for sending the minutes out later than usual.

Action: All. To note the minutes and any actions.

48 Roles and responsibilities of Portfolio Holder for Leisure, Culture and Planning (Councillor Pavlos Kotsonis)

Provided a summary of his portfolio roles and responsibilities including

- relationship to national and local planning policy (can influence the latter, campaign on the former)
- role of Local Plan in setting framework for Planning Team to work to often more ambitious requirements than national policy

- vice chair of Transport Planning Board and member of Joint Planning Advisory board
- relationship with neighbouring councils "duty to cooperate" e.g. waste management, housing targets
- provides political steer i.e. policy direction, strategy and budget; operational management led by Paul Seddon and planning team officers
- can't approve or reject planning applications this is role of planning authority and officers, but has influence through decisions on planning policy
- forthcoming Carbon SPD will help support planning decisions, delivery of active travel options, sustainable transport, walking and cycling etc.

Discussion points included:

- aspirations such as CN28 seem to get overlooked in the delivery of planning policy, and decisions on development proposals
- relationship between planning and non-planning policy in the council
- relationship between local and national planning policy
- role of Active Travel England
- National Planning Policy Framework and Planning White Paper
- cycle parking standards, often standards are below those set out in policy
- duty to "enable development" to meet national targets, housing etc, which may mean compromising ambitions set in local plan/ local planning policy
- monitoring and enforcement capacity is limited (e.g. re green space conditions in planning application approvals)
- planning checklist for planners exists and has previously been shared with LAF (includes e.g. cycle parking)
- role of LAF, NOSF (and other voluntary bodies) is valued by council (e.g. when commenting on planning application or SPDs) because our voice can add weight to the ambitions the council hopes to achieve (e.g. CN28)

Action: Cllr Pavlos to advise whether the council plans to respond to the latest National Planning Policy Framework/ Planning White Paper. Reiterated that LAF members should always contact him on specific issues, and where relevant, copy into emails.

49 Active Travel Social Prescribing programme (Jennie Maybury, City Council Transport Strategy team)

Jennie outlined the Active Travel Social Prescribing Project part of a national pilot with £1.58m of national funding to provide walking and cycling activities through the social prescribing workstreams. The project will focus on 3 areas of Nottingham, St Ann's/Sneinton, Western Nottingham and Bulwell. Feasibility stage in spring 2022 engaged 64 stakeholders across 20 partner organisations which confirmed that it was important for the programme to be "for and run by people like me" (see presentation attached to these minutes).

Four levels of initiatives:

- 1. community based/ family friendly
- 2. personalised designed to be inclusive for those experiencing mental health or social isolation
- 3. hospital trust "walking clinics"
- 4. social prescribers advocates

The GoJauntly is a free walking app which offers

- free walking routes
- dynamic green routes
- nature notes

A partnership package with Go Jauntly will allow the Council to develop Nottingham specific content including options for

- audio enhanced content
- ability to download map content offline (to save on data)

Some Nottingham content already exists on the App and intention is to include some of existing self-guided routes in Nottingham (e.g. park walks & LAF walks) where these are appropriate (e.g. short, easily accessible / no steps / steep gradients, level surfaces / routes)

Action: All LAF members are encouraged to download and try the free GoJauntly app and provide feedback and suggestion for routes in the 3 project delivery areas. Send comments to John Lee, john.lee@nottinghamcity.gov.uk.

Discussion points included the following

- challenge of pulling together all the walking opportunities (guided, self-guided, other)
 in one place when different partners are involved and there are different sources of
 information
- Notts Guided Walks ambition to provide calendar of all guided walks in Nottingham and Nottinghamshire was noted
- NOSF "Green Map" ambition to be repository of all things green, also accessibility issues which include
- digital / non digital
- diversity (e.g. in promotional material)
- disability & perception of walking (e.g. "rambling"/ "rucksacks") can put some people off

49(a) New item (not on the agenda) e-scooters update from Adam Escott, Superpedestrian

Adam updated on the national & local e-scooter trials which has been extended to May 2024, with Superpedestrian providing Nottingham's trial e-scooters. Presentation included the following (see Adam's presentation attached to these minutes).

- new design features of the e-scooter (designed "in-house" by Superpedestrian) and developing technologies to encourage good / safe use and monitor usage
- the trial will feed into future legislation on e-scooter usage
- "education first" approach to dealing with e-scooter misuse

limited discussion time, but points raised included the following

- limited number of "wardens" to support e-scooter monitoring/ enforcement
- issues re pavement riding, 2 riders and use of non-trial / unauthorised scooters
- Nottingham Trent University currently advertising for PhD students to research e-scooters and user behaviours, link here https://www.ntu.ac.uk/research/find-a-phd-
